## **HIDDEN VALLEY WINES and OVERTURE RESTAURANT TERMS AND CONDITIONS – 2011/2012**

### **Dear Bride & Groom**

Thank you for your interest in HIDDEN VALLEY as a potential venue for your special occasion.

Please have a look at the information below and contact us if you have any further questions or queries.

The prices quoted are from January 2011 – August 2011 and from 1 September 2011 – 2012.

### **GENERAL**

The venue can comfortably accommodate up to 140 people inside the restaurant and veranda area. The wine tasting area can be used for dancing or indoor pre-drinks.

There is sufficient cutlery, crockery, glassware for a 100 people, however if you make use of 6-8 or 10 seater tables, an extra 4 trestle tables need to be hired at the bridal parties expense. If the client have more than 100 guests attending, extra chairs and tables will be sourced at the clients' expense.

We have 99 restaurant chairs available and they vary from wicker to leather chrome designer chairs. If you are requesting the usage of these chairs in the downstairs cellar area an amount of R300-00 handling fee will be charged. This will cover the labour and handling of moving the chairs back to the restaurant after the ceremony. However we do not move these chairs to the dam area, extra chairs have to be hired for the bridal party's expense.

Two downstairs cellars are available for ceremonies and both can fit 120 people comfortably.

**Overture Restaurant and Hidden Valley Events Co-ordinator** will only consult with one individual, on all particulars pertaining to the specific function. Overture Restaurant or the events co-ordinator will not be liable to any information given by second parties or any person, body or organization other than the individual representing on the clients behalf.

### **WINE TASTING**

A wine tasting @ R30 per person can be organized for the guests arriving beforehand and this can be organized with the events co-ordinator.

## **TRANSPORT**

A shuttle service to transport guests to and from Hidden Valley can be organized with the events co-ordinator beforehand and the quotation is dependent on the amount of guests for travelling and the area of collection.

## **AFTER CARE**

A baby sitting service can also be organized @ R65 per hour and it is advised that the infants will be looked after in the boardroom area.

## **PACKAGE OPTIONS**

### **A. SUMMER PACKAGE - FULL DAY**

**The fee for hiring the venue is R 20 000-00, and this rate includes –**

- exclusive use of Overture Restaurant, the cellar and Hidden Valley gardens and parking;
- the venue's manager on duty to oversee the function;
- the restaurants' waiters and bar staff for the duration of the function;
- security guard to direct the guests and secure the vehicles during the function;
- staff will guide the guests to the ceremony / reception or pre-drinks area in order to ensure a smooth order of events;
- the venue's crockery, cutlery, glasses, linen, napkins and table cloths and the venue's existing furniture, including tables and chairs;
- set up of chairs for ceremony (hired chairs or venue's chairs);
- the ceremony lawn area overlooking the Helderberg mountains and surrounds;
- A backup generator in the case of electricity shortage and wheelchair friendliness;
- Cellar door prices for our Hidden Valley & Land's End wines;
- Sonos music system in ceremony hall.

PLEASE NOTE: Breakages will be charged for.

**The wedding venue fee will increase with effect 1 September 2011.**

**The venue fee excludes the following:**

- Tent hiring
- Chairs for the cellar
- Stages
- Display furniture and props
- Wines and other drinks;
- A 10% service charge

- Marquee or Bedouin tent hire.

**If using your own service providers then you will supply the following:**

- Flowers and decorations
- Music
- Designer lights
- Décor & flowers
- Creative stationery
- Bridal supplies
- Trial mock-up & styling
- Set up & clearing on the day

**B. HALF DAY PACKAGE (Applicable during the whole year)**

**The fee for hire of the venue is R12 000-00 (new booking rate) and this includes –**

- exclusive use of Overture Restaurant, wine tasting centre, Hidden Valley gardens and parking from 4h30 the evening only or from 09:00 – 17:00.
- the venue's manager is on duty to oversee the function until handing over to Overture for dinner
- the restaurants' waiters and bar staff for the duration of the function;
- security guard to direct the guests and secure the vehicles during the function.
- staff will guide the guests to the ceremony / reception or pre-drinks area in order to ensure a smooth order of events.
- the venue's crockery, cutlery, glasses, linen, napkins and table cloths and the venue's existing furniture, including tables and chairs.
- set up of chairs for ceremony (hired chairs or venue's chairs).
- Cellar door prices on our Hidden Valley & Land's End wines.

The half day wedding hire will increase with effect 1 September 2011.

**C. AUTUMN/WINTER PACKAGE (May – September)**

**The fee for hiring the venue is R17 000-00 and this fee includes:**

- exclusive use of Overture Restaurant, the cellar and Hidden Valley gardens and parking;
- the venue's manager on duty to oversee the function;
- the restaurants' waiters and bar staff for the duration of the function;
- security guard to direct the guests and secure the vehicles during the function;

- staff will guide the guests to the ceremony / reception or pre-drinks area in order to ensure a smooth order of events;
- the venue's crockery, cutlery, glasses, linen, napkins and table cloths and the venue's existing furniture, including tables and chairs;
- set up of chairs for ceremony (hired chairs or venue's chairs);
- the ceremony lawn area overlooking the Helderberg mountains and surrounds;
- A backup generator in the case of electricity shortage and wheelchair friendliness;
- Cellar door prices for our Hidden Valley & Land's End wines;
- Sonos music system in ceremony hall.

PLEASE NOTE: Breakages will be charged for.

#### **D. MID-WEEK PACKAGE (Monday – Friday)**

**The fee for hiring the venue is R17 000-00 and this fee includes:**

- exclusive use of Overture Restaurant, the cellar and Hidden Valley gardens and parking;
- the venue's manager on duty to oversee the function;
- the restaurants' waiters and bar staff for the duration of the function;
- security guard to direct the guests and secure the vehicles during the function;
- staff will guide the guests to the ceremony / reception or pre-drinks area in order to ensure a smooth order of events;
- the venue's crockery, cutlery, glasses, linen, napkins and table cloths and the venue's existing furniture, including tables and chairs;
- set up of chairs for ceremony (hired chairs or venue's chairs);
- the ceremony lawn area overlooking the Helderberg mountains and surrounds;
- A backup generator in the case of electricity shortage and wheelchair friendliness;
- Cellar door prices for our Hidden Valley & Land's End wines;
- Sonos music system in ceremony hall.

#### **SETTING UP & DELIVERIES**

If a service fee has not been pre-arranged with our Function Co-ordinator on any decor set up or display, then we cannot be held responsible or assist in handing out table names, seating plans or table numbers. This has to be **pre-arranged** by the bridal party.

If the bridal party are using their own suppliers, Hidden Valley and Overture cannot be held responsible for any damages or changes made to any displays or decor.

Hidden Valley and Overture reserves the right to move all chairs, tables and decor indoors on account of bad weather without consulting the bridal party.

None of the staff at Hidden Valley or Overture can be held responsible or assist in any music or entertainment via laptop or IPOD or assist in any DJ activities.  
The bridal party has to arrange with third party for assistance.

If any light fixtures and decorative items have not been removed from the reception area before 09:00am on the day after the event, we will unfortunately charge an extra R600-00 service fee.

The rest of the goods can be collected from the storage facilities on the following day before 09:00am.

## **EQUIPMENT**

**Should the client source** the equipment themselves it must be delivered 24hrs before the function at a pre-arranged time with our Function Coordinator. Should equipment be delivered more than 24hrs before the function a R500.00 holding fee will be charged and added to the final bill unless permission is given by Overture Restaurant.

**Any equipment** that has been sourced by the client or equipment belonging to third parties sourced by the client must be removed from the premises by the client before 09:00am the following day. Should any equipment that has been outsourced by the client to a service provider not be removed before 09:00am the following day and prevents Overture Restaurant from trading as per normal, the client will be responsible for the payment of R25 000.00 to compensate for loss of revenue and the cost of reimbursing further clients for the inconvenience. This amount is to be settled within one month of the scheduled date of the function.

## **BREAKAGES**

**Any breakages** will be calculated after the event and charged accordingly by Overture Restaurant.

**Overture Restaurant** will charge and add to the final bill any and or all breakages that should occur during the time of the function made by any of the guests that are attending the function as well as any persons or third parties sourced by the client.

## **APPOINTMENTS**

**Consultation** between the client, Overture Restaurant and the Hidden Valley Events Coordinator, on site inspections or meetings will only take place with an appointment. We reserve the right not to disclose any information should the client arrive without an appointment.

## **DAMAGE OR LOSS**

**Overture Restaurant and Hidden Valley Wines** will not be held responsible for any form of loss, damage or injury sustained to any person attending the function that should incur due to any equipment, persons or third parties invited or sourced by the client.

## **CATERING**

**Overture Restaurant** will be the sole supplier of food and beverages at our wedding. The price per head will be **R270-R350** depending on your choice or structure of the meal. The basic menu will include one welcoming drink per guest, canapés, fresh breads, a three course meal and tea or coffee and petit fours at R350 per person.

Overture Restaurant will be responsible for catering up to 100 persons, anything above this figure, extra hiring will be sourced at the clients' expense to be added to the final invoice.

The chef prefers tailor made menus for every special occasion, therefore we do not provide set menus. The menu is just a broad outline of what can be done.

## **WINES & BEVERAGES**

Hidden Valley will be the sole supplier of wine at your function, however if you have a request for any special beverages like Sparkling or Desert wine, Overture restaurant will source the specific request for you.

A gratuity equal to 10% of the amount payable for food and beverages served by Overture Restaurant will be included in the final food and beverage invoice.

In terms of beverages, you can only select HIDDEN VALLEY wines from our wine list. A full cash bar will be available. Please arrange for the bar to be cash or account. Should you require any other beverages please notify us prior to your function. Only cold beverages can be served by the dam area, while the canapés & pre-drinks will be served upstairs by the ramp or veranda area.

## **TIME**

The bar will close at 00:00 am, but if requested that the bar remain open past 0:00 am, a charge of R2000 per hour will apply up until 2:00 am, which is the latest time the bar will remain open.

**We allocate 8 hours** for an event; if the function is delayed Overture we will charge for staff and chefs at an hourly rate.

## **BOOKING & PAYMENT**

### **DEPOSIT**

Should you decide to book with us, your function date will be reserved for 14 days. After this period Hidden Valley requires a deposit of 50% of the venue fee to confirm your booking. If no deposit is received within this period, the booking will automatically be

cancelled and the venue will be made available to other clients. The deposit becomes non-refundable 30 days from the reservation date.

#### **BALANCE**

The balance of the function fees will become due and payable **2 weeks** prior to the function.

#### **CANCELLATION**

Cancellations have to take place 2 months prior to your function for a full refund of your deposit. ***No refunds will be given if cancellation takes place within 2 months of the function.***

#### **FINAL PAYMENT TO OVERTURE**

Final payment of the bar (Overture) and service fee will be made on the evening of the function, and then the final invoice will be presented on the bar closing. Payment can be done via internet transfer, credit card or cash. No cheques accepted.

Full payment will be made on the evening of the function with the individual responsible, unless written permission for another form of payment or delayed payment has been given by Overture Restaurant. The final invoice will be represented to the client upon bar closing.

**Should the client** for whatever reason decide to cancel the function, reduce the number of guests without giving 2 weeks written notice to Overture Restaurant, Overture Restaurant holds the right to charge for the quoted amount of guests.
